●SEPTIC INSTALLATION

Septic systems are required for expansion of living space, an increase in ridge line, expansion of foot print, demo, new house and to replace failed systems. Applicant shall hire a septic designer and back hoe operator to dig the test pits and design the system. The Town of Rye consultant, Dennis Plante, will witness the test pits and review the design for compliance with the Town regulations/building code prior to sending to the State of NH for review. The designer will coordinate directly w/Dennis Plante for scheduling of required inspections. Five (5) sets of completed plans shall be delivered to the Building Department Office with a stamped envelope and a check to be mailed to the State. Three will be mailed to the State; one will be retained in the Building Department and one is retained by the Rye Water District.
