**Rye General Code Section 35-14.** Whenever an approval for a new design has been obtained pursuant to this section, the new design shall be installed as a condition of issuance of the building permit for construction or change of use unless specifically waived by the Building Inspector and so noted on the construction permit. Waiver by the Building Inspector must be accompanied by a report from a professional of competent authority certifying that the existing system is in good working order and that failure is not anticipated due to the change proposed. The new design shall be installed if the existing system fails or is for any reason to be repaired or replaced.

**All State Rules must be complied with see: Env-Eq 1004.21 When Installation of Replacement ISDS is Required.**
